#### **EXECUTIVE SUMMARY**

The purpose of this report is to provide information regarding the 2020 taxation year options with consideration of COVID 19.

#### **BACKGROUND**

#### **ANALYSIS SUMMARY:**

Section 197 of the *Community Charter* states that local governments are required to submit an adopted Tax Rate Bylaw to the Province on or before May 15<sup>th</sup> of each year, setting out the rates for the current year. Prior to adopting a tax rate bylaw, Councils must first adopt a Financial Plan Bylaw.

Due to COVID19, municipalities within BC are considering the financial implications on taxpayers, and giving consideration to rate increases, penalties, and due date. Some municipalities have elected to extend the due date to September 1<sup>st</sup>; others have elected to split the 10% penalty into two separate 5% penalty due dates.

Example:

<u>July 2<sup>nd</sup></u> – Tax Due Date #1 – All balances after July 2<sup>nd</sup> will receive a 5% penalty.

<u>August 1<sup>st</sup></u> – Tax Due Date #2 – All balances after August 1<sup>st</sup> will receive a **5% penalty**.

During a recent Regional CAO COVID meeting, it was brought forward that there could be mutual benefits to streamlining process amongst our neighbouring municipalities; ie: aligning due dates, penalty amounts, etc. CAO's and CFO's are currently waiting to see if a legislative decision will be made at the Provincial level, prior to committing, and will also await information from the Regional District on the requirements of paying the annual requisition amounts.

It is recommended that Council wait until the May meeting to make a decision on tax schemes for 2020. At that time, staff will have a better understanding of Provincial/Regional/local decisions, and will be able to prepare the appropriate financial scenarios for Council to review.

The Community Charter outlines provisions for property taxes:

- <u>Section 234</u>: Property taxes are due on July 2<sup>nd</sup> of the year. The Lieutenant Governor may make regulations establishing penalties and interest that must be applied by municipalities in relation to payments made after the tax due date.
- Section 235: A Council may, by bylaw, establish one or more dates on which all or part of the taxes are due under this section. The Bylaw may establish discounts, penalties, interest, and set terms, conditions, and procedures in relation to payments.

#### FINANCIAL IMPACT

Altering due date and penalty date may affect cash flows.

#### **BENEFITS & NEGATIVE IMPACTS**

Once the Financial Plan is set, Council must adopt a tax bylaw to levy taxes to collect the monies outlined in the plan. Taxes are necessary to meet the operating requirements of the municipality.

#### LEGISLATIVE IMPACTS, PRECEDENTS, POLICIES

- Pursuant to the Local Government Act Section **512** (1) (b) the minimum frontage that the Section 197 of the *Community Charter* states that Local Governments are required to submit the adopted municipal Tax Rate Bylaw to the Province on or before May 15<sup>th</sup> of each year.
- A 10% penalty is applied to all balances outstanding after the due date, July 2<sup>nd</sup>.
- All balances outstanding at December 31<sup>st</sup> are transferred to *arrears taxes* on January 1<sup>st</sup>, and begin accruing interest at a daily rate set by the Province.
- Taxes outstanding at year three are considered *delinquent taxes*, and are at risk of tax sale if the delinquent amounts are not paid by 10am on the day of the tax sale.

#### **DISCUSSION**

And further, that staff be directed to prepare the 2020 Tax Rate Bylaw for consideration.

- 2. That in addition to waiving municipal tax rate increases for the 2020 tax year due to COVID19, Council <u>not alter</u> the tax collection scheme for 2020, and the due date remain at July 2<sup>nd</sup>.
- 3. That Council defer making a decision on tax scheme changes for the 2020 year to the May meeting, and that staff be directed to provide information to Council on Provincial, Regional, and local decisions for review.

# All BC Parks closing

https://news.gov.bc.ca/21966 Wednesday, April 8, 2020 8:00 AM Victoria - BC Parks is immediately closing all provincial parks in response to the widespread call for increased action to address COVID-19.

The closure responds to both the federal and provincial directives that people should stay close to home to reduce COVID-19 transmission risk. This temporary measure means people should not be going to provincial parks until further notice.

While many people are observing the physical distancing requirements set by the provincial health officer The decision to close the park system is informed by continued feedback from RCMP, local government, First Nations, local search-and-rescue (PHO), some continue to ignore the order, making enforcement in a wilderness setting challenging.

BC Parks is also extending the ban on all camping in provincial parks until May 31, 2020, in alignment with neighbouring jurisdictions The timing of this decision is important given the upcoming long weekend and the beginning of the busy season for outdoor recreation and and the temporary closure of Canada's national parks. Refunds for bookings up to May 31 will be sent automatically. As previously announced, the Recreation Sites and Trails BC (RSTBC) branch of the Ministry of Forests, Lands, Natural Resource Operations and Rural Development has also closed its campgrounds and amenities in response to the COVID-19 situation.

BC Parks has taken a scaled and phased in approach to limiting park access following PHO requirements and the latest COVID-19 transmission data. BC Parks recognizes the value of nature in contributing to public health and wellness and will expand access to the park system as soon as the PHO indicates it can be done without increasing the risk of COVID-19 transmission.

#### **Executive Summary**

The purpose of this report is to provide information regarding the process for the amendment to Zoning Bylaw No. 466 - 2011 for rezoning a property that is currently Park and Institutional to Residential, known as the Zion (United) Church.

#### **Discussion**

#### **BENEFITS & NEGATIVE IMPACTS:**

Staff do not have any benefits or negative impacts to report for the proposed land designation change.

There is a financial impact due to the cost of advertising as required by the *Local Government Act*.

#### LEGISLATIVE IMPACTS, PRECEDENTS, POLICIES:

A public hearing in accordance to the *Local Government Act* Division 3 is to be held after the First Reading and before the Third Reading of the OCP and Zoning Bylaws. The public hearing was held for the OCP, as in accordance to Division 3 464 (2a&b), and therefore there is not a public hearing required for a Zoning Bylaw if it is in accordance to the OCP Bylaw which is subject to the Zoning Bylaw.

Under Division 3, Section 466 there are still advertisement required to waive the public hearing before third reading and final adoption. First and second reading for the Zoning Amendment Bylaw were passed by Council at their regular Council meeting in January 2020.

The province has requested Municipalities waive a public hearing when legislation allows due to the Provincial State of Emergency called due to COVID 19.

Council cannot pass the staff recommendation below unless they pass both recommendations in L1 for final consideration and adoption of the two OCP Bylaw Amendments.

#### Recommendation:

That Village of Silverton Council, in accordance with the *Local Government Act* Division 3, 464 (2a&b) waive the public hearing for Zoning Map Amendment Bylaw No. 514 – 2020.
