The Council of the Village of Silverton requests the CRTC reverse its decision 2010-255 to allow incumbent Internet Service Providers (ISP's) to charge their customers including wholesale customers (smaller independent ISP's) based on a predetermined threshold of bandwidth use.

This decision allows incumbent ISP's to impose unjust financial limitations on how many gigabytes of usage their independent competitors can provide their customers, thereby severely limiting diversity in Canada's telecommunications sector.

Rural communities such as Silverton have fought for many years just to have a reasonable level of Internet service. This service is usually provided by community and small ISP's who must purchase their service from incumbent ISP's. It is imperative these small independent ISP's remain competitive and their service is sustainable.

Incumbent ISP's have no interest in supplying Internet service to rural Canada as it is not economically viable. This decision reverses much of the work communities and governments have done to eliminate the digital divide in Canada's rural communities. Businesses and individuals in rural areas need unmetered and affordable access to the Internet to remain competitive and conduct business in today's market place. Many rural communities already pay a premium for service due to the cost of last mile delivery. Some of Canada's rural communities still lack communication services found in third world countries.

The CRTC needs to foster communications in rural Canada and not hinder progress made to date.

Resolution: Usage-Based Internet Billing in Silverton

WHEREAS the Canadian Radio-television Telecommunications Commission (CRTC) has, in Telecom Decision CRTC 2010-255, allowed incumbent Internet Service Providers (ISPs) to charge their customers, including wholesale customers (smaller independent ISPs), based on predetermined thresholds of bandwidth use;

WHEREAS this decision has allowed incumbent ISPs to impose unjust financial limitations on how many gigabytes of usage their independent competitors can provide to their customers, thereby severely limiting diversity in Canada's telecommunications sector;

WHEREAS this pricing regime will result in impediments to independent ISPs' abilities to financially differentiate the services they provide to consumers from the services of incumbents, which harm competition and market innovation;

WHEREAS usage-based billing, or metering discriminates against certain forms of information, such as audio and video, insofar as it charges consumers more for content that requires the use of a large amount of gigabytes;

WHEREAS these high prices will act as a tax on innovation, free expression, and empowerment, as those who produce content become less able to produce and disseminate their work freely;

WHEREAS this pricing regime will increase the overall cost of Internet access for end- users, thereby deepening the digital divide, which is antithetical to the CRTC's broadband accessibility mandate;

WHEREAS usage based billing limits Silverton residents' ability to access online services, to become educated, and to communicate with others, and hampers the free and full exchange of information;

THEREFORE BE IT RESOLVED that Silverton Village Council will write to CRTC to urge them to reverse Telecom Decision CRTC 2010-255 and to prevent incumbent ISPs from imposing usage-based billing on the independent ISPs that purchase wholesale broadband, and that this correspondence will be copied and sent to the relevant Provincial and Federal Ministers and the Regional District of Central Kootenay.
