(a) Letter from Wayne McCrory regarding "Lot 23" and the Valhalla Foundation After discussion it was Moved and Seconded

"That Council recommend this property be exempt from taxation under Section 197(1)(a) of the *Community Charter*. Further, Council would allow the Foundation to erect a small sign post in order to place a sign at the top of the trail."

8. BRING FORWARD FROM COMMITTEE OF THE WHOLE:

(a) Bi-weekly garbage pickup – potential savings

Acting CAO Rogers explained that there would be minimal savings in going to a biweekly garbage pickup from a weekly pickup, during the winter months, as it would mean the same amount of garbage would be picked up every two weeks, requiring two trips to the transfer station instead of one every week. Any savings would come from labour which is estimated to be about \$50 every two weeks, or \$100 per month.

After discussion it was Moved and Seconded

"That it be recommended the Village of Silverton go to a bi-weekly garbage pickup for a 3 month trial period during January, February and March 2013"

It was also suggested that additional encouragement to the public to recycle may reduce the amount of garbage to be picked up, thereby reducing the number of trips to the transfer station.
