SUBJECT: Public Notice Bylaw No. 532, 2022

PURPOSE: To seek adoption of the proposed bylaw.

OPTIONS:

1. Adopt the bylaw. The new rules will take effect upon final adoption

2. Refer back to staff for further review and report. Adoption of the bylaw will be delayed.

RECOMMENDATION:

THAT Public Notice Bylaw No. 532, 2022 receive three (3) readings.

ANALYSIS:

- A. Background: In February 2022, the province updated section 94 of the Community Charter to allow local governments to either continue to use the default publication requirements of publishing in a newspaper once each week for two consecutive weeks or adopt a bylaw to provide for alternative methods of publication (i.e., a public notice bylaw).
 This change in legislation is welcome in small communities like Silverton where the lack of a newspaper that publishes at least weekly has significant impacts on advertising schedules, causing delays for applicants.
- B. Discussion: The province has prepared written guidance material and delivered workshops for election staff to ensure that municipal bylaws effectively inform the public of opportunities to participate in local government decision making and share their views. The methods used must be reliable (providing factual information, published regularly), suitable (all information is legible, meeting timing requirements, notice can be revisited) and accessible (available to a diverse audience, easy to find).
 By requiring three familiar and separate modes of notice (newspaper, website, bulletin board) the proposed approach aims to reach a broad audience. This approach satisfies the principles of reliability, suitability and accessibility and encourages openness and transparency in local government operations. Specific details are included in the accompanying Public Notice Policy so that they can be modified if circumstances require.

THE CORPORATION OF THE VILLAGE OF SILVERTON BYLAW NO. 532, 2022

A BYLAW TO AUTHORIZE ALTERNATE MEANS OF PUBLISHING PUBLIC NOTICES

WHEREAS the Community Charter provides that Council may, by bylaw, provide for alternative means of publishing a public notice;

AND WHEREAS Council has considered the principles of reliability, suitability and accessibility as they apply to the means of publishing a public notice;

NOW, THEREFORE, Council of the Village of Silverton, in open meeting assembled, **ENACTS AS FOLLOWS:**

1. Title

This Bylaw may be cited as "Public Notice Bylaw No. 532, 2022".

2. Definitions

Village Office means the Village of Silverton Municipal Office located in Silverton, BC

Village Office Bulletin Board means the public notice posting place located at the Village Office

Municipal website means the Village of Silverton website

Village means the Village of Silverton

3. Advertising Method

3.1. Any notice required to be advertised in accordance with section 94 of the Community Charter may instead be given, in accordance with section 94.2 of the Community Charter, by publishing the notice once in a local newspaper, electronically posting a copy of the notice on the municipal website, and posting a copy of the notice at the Village Office Bulletin Board.

4. Effective Date

This bylaw shall take effect upon adoption.

THE CORPORATION OF THE VILLAGE OF SILVERTON

BYLAW NO. 533, 2022

A BYLAW TO ESTABLISH PROCEDURES FOR ELECTIONS AND OTHER VOTING

The Council of the Village of Silverton, in open meeting assembled, enacts as follows:

1. Title

This Bylaw may be cited as "Election Procedures Bylaw No. 533, 2022".

2. Access to Nomination and Endorsement Documents

- 2.1. The chief election officer may give public access to nomination documents by the internet or other electronic means from the time of filing until 30 days after the declaration of the election results.
- 2.2. The chief election officer may give public access to elector organization endorsement documents by the internet or other electronic means from the time of filing until 30 days after the declaration of the election results.

3. Elector Registration

The most current available Provincial list of voters prepared under the Election Act shall form the register of resident electors and shall become the register of electors on the 52nd day prior to general voting day.

4. Advance Voting Opportunities

- 4.1. Required advance voting will be held in accordance with the Local Government Act.
- 4.2. The chief election officer may:
 - a. establish additional voting opportunities to be held in advance of general voting day; and
 - b. designate the voting places and set the voting hours for these voting opportunities.

5. Special Voting Opportunities

- 5.1. The chief election officer may establish the dates, locations, and voting hours within the limits set out in the Local Government Act, for the special voting opportunities.
- 5.2. The following restrictions apply as to who may vote at the special voting opportunities:
 - a. Only electors who, on the date on which the special voting opportunities are held, are residents or patients or family members thereof, or are employees of the facilities at which special voting opportunities are conducted.
- 5.3. The chief election officer is authorized to limit the number of candidate representatives who may be present at the special voting opportunities.

6. Mail Ballot Voting

6.1. Mail ballot voting shall be permitted in accordance with the provisions of the Local Government Act.

- 6.2. The chief election officer shall keep sufficient records so that challenges of the elector's right to vote may be made in accordance with the intent of section 126 of the Local Government Act.
- 6.3. The chief election officer shall determine the time limits in relation to voting by mail ballot.

7. Resolution of Tie Vote

7.1. In the event of a tie vote after a judicial recount, the tie vote will be resolved by conducting a lot in accordance with section 151 of the Local Government Act.

8. Repeal

Village of Silverton Elections Procedure Bylaw No. 470, 2011 and all amendments thereto are hereby repealed.

POLICY STATEMENT:

When providing alternative means of public notice in accordance with Section 94.2 of the Community Charter, the Village of Silverton shall publish as follows:

Local Newspaper: Valley Voice

➤ Village Website: <u>www.silverton.ca</u>

➤ Village Office Bulletin Board: the notice board outside of the Village Office at 421 Lake Avenue

POLICY SCOPE:

This Policy applies to all public notices given in accordance with Public Notices Bylaw No. 532, 2022 and Section 94.2 of the Community Charter.

POLICY PURPOSE:

To clarify the application of Public Notice Bylaw No. 532, 2022

DEFINITIONS:

The definitions found in Public Notice Bylaw No. 532, 2022 apply to this policy. In addition:

Local Newspaper means the Valley Voice

Village Website means www.silverton.ca

Village Office Bulletin Board means the notice boards outside the Village Office at 421 Lake Avenue, Silverton, BC

PROCEDURE:

Mayor

1.	The principles of reliability, suitability and accessibility, and a goal of open and transparent government will guide staff choices regarding the publication of public notices.
2.	Additional methods of publication, including but not limited to the following, car be used at the discretion of staff:

A BYLAW TO AMEND THE COUNCIL PRCEDURES BYLAW 512, 2019

WHEREAS the Council of the Village of Silverton has adopted the Council Procedure Bylaw No. 512, 2019

AND WHEREAS the Council of the Village of Silverton deems it necessary and expedient to amend the Council Procedure Bylaw No. 512,2019

NOW THEREFORE the Council of the Village of Silverton in open meeting assembled, **ENACTS AS FOLLOWS**:

CITATION

1. This Bylaw may be cited for all purposes as the Council Procedure Amendment (Electronic Meetings) Bylaw No. 531, 2022.

AMENDMENTS

2. Part 1 Section 2 – Definitions

Section 2 is amended by changing the definition of "Public Notice Posting Places" to read as follows:

means the notice board at the Village Office and the Village of Silverton website

3. Part 2 Section 8 – Electronic Meetings

Section 8 of the Procedure Bylaw is repealed and replaced in its entirely with the following:

- 8. (1) A regular or special council meeting or other Council committee meeting may be conducted by electronic means
 - (2) Electronic meetings will follow the rules established by the Community Charter Section 128 and Council policies pertaining to electronic meetings.
 - (3) Advance public notice of meetings that are open to the public, will be posted in the public notice posting places according to the procedures established in this bylaw for giving notice, and will include:
 - (a) the way in which the electronic meeting will be conducted, and
 - (b) the place where the public may attend to hear, or watch and hear, the proceedings.

This concert has been a tradition for the past 25 years. The concert was usually held the first weekend in February in Memorial Hall and was a fundraiser for the PreSchool.
